

**Note for foreign citizens sent to study within the quota  
of the Ministry of Science and Higher Education of Russian Federation  
at Sochi State University**

1. A foreign citizen sent to the Sochi State University (SSU) within the quota for admission of foreign citizens to study in the Russian Federation enters the territory of Russian Federation with a visa issued at the Consular Department of the Russian Federation in the country of permanent residence, on a basis of an invitation issued by the Ministry of Science and Higher Education of the Russian Federation.

2. **Validity period of a foreign passport** for entry into the Russian Federation must be **at least 18 months** from the visa expiration date. Student's passport must have at least two blank page spreads to extend the visa.

3. To enter the territory of Russian Federation, a foreign student must issue a medical insurance policy valid on the territory of Russian Federation for a period of at least one month, issued in the country of permanent residence, which will be extended in the Russian Federation for the entire period of study at the time of its expiration.

4. When crossing the state border of the Russian Federation, a foreign student must receive a migration card form, which indicates the purpose of arrival – STUDY. It is NOT allowed to underline the words WORK or PRIVATE ENTRY!!!

5. A foreign citizen who arrived to study at the SSU must register at the International Relations and Media Relations Department (94 Plastunskaya str., office 318/2) within 3 working days from the date of arrival to the Russian Federation.

It is necessary to have the following documents:

- **foreign passport, translation of all pages of the foreign passport** (notarized);
- **migration card** that indicates the purpose of arrival – **STUDY**;
- **medical insurance policy** valid on the territory of the Russian Federation;
- **photo 3,5\*4,5 - 4 pieces.**

**Additional information:**

After being registered, foreign citizens arrived to the Russian Federation for study must undergo mandatory state fingerprint registration, photographing and medical examination within 90 days from the date of entry into the Russian Federation. These procedures are carried out at the Regional Migration Center in Krasnodar. The procedure of medical examination is chargeable (paid by the students themselves). 6. **To get accommodation in the dormitory**, a foreign citizen needs to come to the Youth Policy and Nurturing Activities Department (94 Plastunskaya str., office 153/2) with the following documents:

- A document certifying the identity of a foreign citizen in the Russian Federation and notarized translation of all pages of a foreign passport into Russian;
- A medical insurance policy valid on the territory of Russian Federation;

- Copies of medical documents (certificates) of the country of permanent residence and their notarized translation into Russian:

- Certificate of absence of HIV and AIDS (valid for 6 months);
- Chest x-ray (valid for 1 year);
- Certificate of RW absence (valid for 2 months);
- Certificate of hepatitis C and B absence (valid for 3 months);
- Certificate from a dermatovenerologist (valid for 6 months);
- Certificate from an infectious disease specialist about past infectious diseases;
- Copy of a certificate form 156/-93 – list of all vaccinations (unlimited validity period);
- Photo 3\*4.
